Military Readiness Enhancement Act of 2007 (110th Congress H.R. 1246)

HR 1246 IH
110th CONGRESS
1st Session
H. R. 1246

IN THE HOUSE OF REPRESENTATIVES

A BILL

To amend title 10, United States Code, to enhance the
readiness of the Armed Forces by replacing the current
policy concerning homosexuality in the Armed Forces,
referred to as 'Don't Ask, Don't Tell', with a policy of
nondiscrimination on the basis of sexual orientation.

Be it enacted by the Senate and House of Rep-
resentatives of the United States of America in Con-
gress assembled,

SECTION 1. SHORT TITLE.

This Act may be cited as the 'Military Readiness
Enhancement Act of 2007'.

SEC. 2. PURPOSE.

The purpose of this Act is to institute in the Armed
Forces a policy of nondiscrimination based on sexual
orientation.

SEC. 3. REPEAL OF 1993 POLICY CONCERNING HOMOSEXUALITY IN THE ARMED FORCES.

The following provisions of law are repealed:

(1) Section 654 of title 10, United States Code.

(2) Subsections (b), (c), and (d) of section 571
of the National Defense Authorization Act for Fiscal
Year 1994 (10 U.S.C. 654 note).

SEC. 4. ESTABLISHMENT OF POLICY OF NON- DISCRIMINATION BASED ON SEXUAL ORI- ENTATION IN THE ARMED FORCES.

(a) Establishment of Policy- (1) Chapter 37 of title
10, United States Code, is amended by adding at the
end the following new section:

'Sec. 656. Policy of nondiscrimination based on sexual
orientation

'(a) Policy- The Secretary of Defense, and the
Secretary of Homeland Security with respect to the
Coast Guard when it is not operating as a service in
the Navy, may not discriminate on the basis of sexual
orientation against any member of the armed forces
or against any person seeking to become a member
of the armed forces.

'(b) Discrimination on Basis of Sexual Orientation
- For purposes of this section, discrimination on the
basis of sexual orientation is--

'(1) in the case of a member of the armed forces,
the taking of any personnel or administrative action
(including any action relating to promotion, demo-
tion, evaluation, selection for an award, selection for

a duty assignment, transfer, or separation) in whole
or in part on the basis of sexual orientation; and

'(2) in the case of a person seeking to become
a member of the armed forces, denial of accession
into the armed forces in whole or in part on the basis
of sexual orientation.

'(c) Personnel and Administrative Policies and
Action- The Secretary of Defense, and the Secre-
tary of Homeland Security with respect to the Coast
Guard when it is not operating as a service in the
Navy, may not establish, implement, or apply any
personnel or administrative policy, or take any per-
sonnel or administrative action (including any policy
or action relating to promotions, demotions, evalua-
tions, selections for awards, selections for duty as-
signments, transfers, or separations) in whole or in
part on the basis of sexual orientation.

'(d) Rules and Policies Regarding Conduct- Nothing
in this section prohibits the Secretary of Defense,
and the Secretary of Homeland Security with re-
spect to the Coast Guard when it is not operating as
a service in the Navy, from prescribing or enforcing
regulations governing the conduct of members of the
armed forces if the regulations are designed and ap-
plied without regard to sexual orientation.

'(e) Re-Accession of Otherwise Qualified Persons
Permitted- Any person separated from the armed
forces for homosexuality, bisexuality, or homosexual
conduct in accordance with laws and regulations in ef-
fect before the date of the enactment of this section, if
otherwise qualified for re-accession into the armed
forces, shall not be prohibited from re-accession into
the armed forces on the sole basis of such separation.

'(f) Sexual Orientation- In this section, the term
'sexual orientation' means heterosexuality, homo-
sexuality, or bisexuality, whether the orientation is
real or perceived, and includes statements and con-
sensual sexual conduct manifesting heterosexuality,
homosexuality, or bisexuality.'

(2) The table of sections at the beginning of such
chapter is amended--

(A) by striking the item relating to section 654; and

(B) by adding at the end the following new item:

'656. Policy of nondiscrimination based on
sexual orientation in the armed forces.'

(b) Conforming Amendments- Title 10, United
States Code, is amended as follows:

(1) Section 481 is amended--

(A) In subsection (a)(2), by inserting ',
including sexual orientation discrimination,' after 'dis-
crimination' in subparagraphs (C) and (D); and

(B) in subsection (c), by inserting 'and
sexual orientation-based' after 'gender-based' both
places it appears.

(2) Section 983(a)(1) is amended by striking
'(in accordance with section 654 of this title and
other applicable Federal laws)'

(3) Section 1034(i)(3) is amended by inserting
'sexual orientation,' after 'sex,'.

SEC. 5. BENEFITS.

Nothing in this Act, or the amendments made by
this Act, shall be construed to require the furnishing
of dependent benefits in violation of section 7 of title
1, United States Code (relating to the definitions of
'marriage' and 'spouse' and referred to as the 'De-
fense of Marriage Act').

SEC. 6. NO PRIVATE CAUSE OF ACTION FOR DAMAGES.

Nothing in this Act, or the amendments made by
this Act, shall be construed to create a private cause
of action for damages.

SEC. 7. REGULATIONS.

(a) In General- Not later than 90 days after the date
of the enactment of this Act, the Secretary of Defense
shall revise Department of Defense regulations, and
shall issue such new regulations as may be necessary,
to implement section 656 of title 10, United States
Code, as added by section 4(a). The Secretary of De-
fense shall further direct the Secretary of each mili-
tary department to revise regulations of that military
department in accordance with section 656 of title 10,
United States Code, as added by section 4(a), not
later than 180 days after the date of the enactment
of this Act. Such revisions shall include the following:

(1) Revision of all equal opportunity and human
relations regulations, directives, and instructions to
add sexual orientation nondiscrimination to the De-
partment of Defense Equal Opportunity policy and to
related human relations training programs.

(2) Revision of Department of Defense and
military department personnel regulations to elimi-
nate procedures for involuntary discharges based on
sexual orientation.

(3) Revision of Department of Defense and
military department regulations governing victims'
advocacy programs to include sexual orientation dis-
crimination among the forms of discrimination for
which members of the Armed Forces and their fami-
lies may seek assistance.

(b) Regulation of Conduct- The Secretary of Defense,
and the Secretary of Homeland Security with re-
spect to the Coast Guard when it is not operating as
a service in the Navy, shall ensure that regulations
governing the personal conduct of members of the
Armed Forces shall be written and enforced without
regard to sexual orientation.

(c) Definition- In this section, the term 'sexual
orientation' has the meaning given that term in sec-
tion 656(f) of title 10, United States Code, as added
by section 4(a).

In memory of a member of America's Greatest Generation

One of my troopers died last week; he was 92 years old. He was a World War II veteran who was drafted into the Army as a boy Private in 1941, and retired a lifetime later as a Major in 1974. I attribute his longevity to the fact that he proudly celebrated everything that he was; he simply didn't worry. He was an American soldier, Jewish, and gay. Last year In the New York City Pride and Veterans' Day parades, when I offered Willet Fields, aged 91 at the time, a sign saying "GAY WWII VET," he eagerly snatched it out of my hands, held it high, and led our contingent with it down Fifth Avenue as a million spectators cheered him on. Policemen guarding the parade route left their posts to shake his hand; and thousands shouted, "Thank you for

serving!" Everyone was inspired. He so very proudly celebrated who he was. He was a sweet little teddy bear of a man with white hair and a barrel chest that everyone wanted to hug.

During and after World War II, Willet Fields served in the Philippines and in the Allied occupation of Germany. He was just another soldier -- unless you happened to take a look at the faded ribbons on his old garrison cap that he proudly wore in our parades; and you would see a WWII medal, American Defense Ribbon, Asiatic Pacific Campaign Ribbon, American Campaign Ribbon, National Defense Ribbon, German Occupation Ribbon, The Armed Forces Reserve Medal, Philippines Liberation Ribbon with Bronze Star, and The Philippine Independence Ribbon.

His relatives, who organized his funeral service, celebrated his life his way. His coffin was draped in an American flag to honor his long service to his country. The female Rabbi conducting the service was from his LGBT congregation. The service was attended by many relatives who flew in from around the country, and by nearly 100 gay and lesbian friends of all ages from SAGE (Senior Action in a Gay Environment), his synagogue CBST (Congregation Beth Simchat



Torah), those he'd worked with in the organization Sons of Israel, and his fellow LGBT Vets -members of AVER (American Veterans For Equal Rights New York). A memorial was held in his honor at the LGBT Community Center in NYC, and another was later held across the country in Los Angeles. For Willet Fields, the inevitable was a triumph rather than a tragedy because his life as a soldier, beloved and caring cousin, fundraiser, and gay rights activist was celebrated in all its fullness.

He so very much wanted to march with us again this coming November in the Veterans' Day Parade; you can be sure he'll be with us. I miss him already.

**VA Medical Centers
Extending Hours**

**Change Benefits New Combat
Veterans, Older Vets**

WASHINGTON (15 June 2007) -- In order to provide more health care for more veterans, especially mental health services, Secretary of Veterans Affairs Jim Nicholson has directed the 153 medical centers of the Department of Veterans Affairs (VA) to keep their doors open longer.

“Illness doesn’t follow a 9-to-5 schedule,” Nicholson said. “I’m directing our medical centers to provide extended hours to ensure we’re there for the veterans who have earned our care.”

Although the extra hours apply to many hospital-based programs and services, Nicholson said his latest decision was based upon a desire to ensure VA’s more than 9,000 mental health professionals are available when veterans need them.

VA operates the largest integrated health care system in the country and the nation’s largest mental health program. About 5.5 million veterans are expected to seek health care from VA’s nationwide system this year, accounting for about 800,000 hospitalizations and 60 million outpatient visits.

In recent months, Nicholson has announced a number of initiatives to improve mental health care for returning combat veterans, including the hiring of suicide prevention coordinators for each medical center, 100 new adjustment counselors for VA’s 207 Vet Centers, and 100 new medical center employees to serve as advocates for the severely wounded.

VA’s mental health experts will gather in Washington in July for a four-day conference reassessing the Department’s programs for veterans, especially veterans from the conflict in Iraq and Afghanistan.

**VA’s Suicide Hot Line
Begins Operations**

**Nicholson:
“Help a Phone Call Away”**

WASHINGTON (30 July 2007) – To ensure veterans with emotional crises have round-the-clock access to trained professionals, the Department of Veterans Affairs (VA) has begun operation of a national suicide prevention hot line for veterans.

“Veterans need to know these VA professionals are literally a phone call away,” said Secretary of Veterans Affairs Jim Nicholson. “All service members who experience the stresses of combat can have wounds on their minds as well as their bodies. Veterans should see mental health services as another benefit they have earned, which the men and women of VA are honored to provide.”

The toll-free hot line number is 1-800-273-TALK (8255). VA’s hot line will be staffed by mental health professionals in Canandaigua, N.Y. They will take toll-free calls from across the country and work closely with local VA mental health providers to help callers.

To operate the national hot line, VA is partnering with the Sub-

stance Abuse and Mental Health Services Administration of the Department of Health and Human Services (HHS).

“The hot line will put veterans in touch – any time of the day or night, any day of the week, from anywhere in the country – with trained, caring professionals who can help,” added Nicholson. “This is another example of the VA’s commitment to provide world-class health care for our nation’s veterans, especially combat veterans newly returned from Iraq and Afghanistan.”

The suicide hot line is among several enhancements to mental health care that Nicholson has announced this year. In mid July, the Department’s top mental health professionals convened in the Washington, D.C., area to review the services provided to veterans of the Global War on Terror.

VA is the largest provider of mental health care in the nation. This year, the Department will spent about \$3 billion for mental health. More than 9,000 mental health professionals, backed up by primary care physicians and other health professionals in every VA medical center and outpatient clinic, provide mental health care to about 1 million veterans each year.

AVER applauds this progress. Timely medical care can make all the difference between a temporary injury or illness and a permanent disability. Suicide rates are known to be higher in the LGBT community than among Americans at large, but many civilian mental health staff are not well versed in **service related** crises which could effect **any** veteran, so the hotline is very welcome news.

MREA returns to Congress

On 28 February 2007, Rep. Marty Meehan (D-MA), chair of the House Armed Services Sub-Committee on Oversight and Investigations, introduced into Congress the Military Readiness Enhancement Act of 2007 (110th Congress H.R.1246). This followed in the footsteps of the News Years statements against Don't Ask Don't Tell (DADT) by former Chairman of the JCS General John Shalikashvili and former Secretary of Defense William Cohen.

Although the 2005 version of this bill (109th Congress H.R.1059) died in committee at the end of the session with just 122 co-sponsors, H.R.1246 headed out of the gate with 110 co-sponsors on board, including several freshman Representatives.

A University of California Blue Ribbon Commission reported in 2006, that DADT has already cost our nation's military more than \$363 million to recruit and train replacements for the more-than 11,000 troops discharged under DADT. That figure includes nearly 800 specialists who were considered to have mission critical job skills, more than 300 of whom were foreign linguists.

In May of this year, a group of 40 Congressmen, led by Rep. Meehan asked the House Armed Services Committee for a hearing to discuss the continuing dismissal of high value Arabic linguists. Their discharge number has now reached 58 total, during a war in which their value is indisputable. Rep. Meehan and others believe this is clear evidence that DADT is a threat to our national security, and unnecessarily puts our troops in harm's way.

On 1 July 2007, Rep. Meehan stepped down from Congress to accept the position as Chancellor of the University of Lowell (Mass.). Since that time, the banner of H.R.1246 has been taken up by Rep. Ellen Tauscher (D-CA).

Rep. Tauscher is the Chair of the House Armed Services Sub-Committee on Strategic Forces, and is also a member of the Air and Land Forces Sub-Committee, and the Oversight and Investigations Sub-Committee. Rep. Tauscher has a high track record of sponsoring / co-sponsoring bills that directly pertain to human rights issues and the support of our Armed Forces service members at home and away.

The march of H.R.1246 continues to progress. The bill currently has 131 co-sponsors, and there is a push to get new hearings on DADT scheduled during 2007. (Full bill text is on page 21)



To help further the progress of this bill it is vital for all of our LGBT veterans and allied supporters to contact their US Representatives, with compelling letters encouraging them to sign on as co-sponsors of "H.R.1246. The Military Readiness Enhancement Act of 2007." Congress has literally hundreds of active bills at any point in time, so please be sure to include the bill number and use the full name of the bill, not the acronym.

the role of AVER secretary. This new office is a good match with my ongoing role as Chair for Web&IT Development, as the AVER web site is a vital tool for facilitating the flow of information and interaction between the membership and officers, and between the various regions of the country."

Mark remains our treasurer, and continues to do an outstanding job. He has been a member of AVER for 3 years, and was one of the founding members of AVER-Florida Gold Coast Chapter in Ft. Lauderdale FL, currently our fastest growing chapter. "Responsible accounting is critical to any organization. I am gratified that you had the confidence to choose me to continue in the position of national treasurer."

The 2007 AVER National Convention was held in Cleveland OH in mid-April, splendidly hosted by NEOAVER. Chapters and members from across the nation attended the proceedings which included delegates from Ft. Lauderdale, New York City & Rochester NY, San Antonio & Houston TX, San Diego, Palm

Springs & Sacramento CA, Chicago & Plainville IL, Cleveland OH & Minneapolis-St. Paul. Just as NEOAVER assured everyone, we would start a bit chilly, but ended up with a gloriously sunny weekend.

Seeing the sights of Cleveland included an amazing tour of the Cuyahoga County Soldiers & Sailors Monument (Civil War) whose spectacular Victorian statuary fills a city square with the "Goddess of Liberty" at the top of a column and four bronze groupings at base depict Navy, Cavalry, Infantry and Artillery. This monument was one of the first in the nation to depict "live action" bronzes instead of the traditional puff-chested statues and busts. The guided tour included the spacious interior, where the marble walls are engraved with the names of more than 9000 local Civil War service members. The tour was capped by a special-request tour of the "catacombs" below, which are normally closed to the public.

The convention's sumptuous open festival of food and drink had invited guests from the Ohio LGBT community including representatives from Equality OH, Cleveland Pride, Transgender American Veterans Association (TAVA), and the Gay People's Chronicle.

On 24 June, we were the Color Guard for the Seattle Pride Parade. Each volunteer wore their uniform, and we had a member of each service for each service flag. I was a little worried about the Marine Flag but the day before a young Marine offered to march with us. Good thing it was an official military function.

CONVENTION PRESENTATIONS:

Janet M. Briggs, MSN, RN, CNP started us off with a presentation on current VA HIV/AIDS research and treatment programs. The VA provides more than 22,000 HIV+ veterans access to the most "bleeding edge" HIV/AIDS treatments and medications in the world, making the VA the nation's largest single provider of HIV health care. Research progress in this field is being led by the VA, and is very promising!

Denny Meyer of AVERNY and James Darby of Chicago presented a colorful history of LGBT service in America's military from the Revolutionary War to the present, and the more than decade-long history of GLBVA/AVER's work to repeal DADT while serving the needs of our own patriotic and courageous LGBT veterans.

Friday's lunch was capped with a presentation by Mike Scheunemeyer and Robert Meyers-Bradley on the United Church of Christ's secular retreat scheduled for August 2007. This event is tailored specifically for returning LGBT war veterans and their partners. The organization's work includes support of LGBT service members and veterans.

A Freedom to Serve Roundtable included Denny Meyer, editor of Military Equality Alliance's "The Gay Military Times," Kathi Westcott, SLDN, and Ben Gomez, AVER. They presented an update on the multi-organizational alliance of those working together to advocate the passage of the Military Readiness Enhancement Act, the congressional bill that would repeal the DADT policy and allow all Americans to volunteer to serve openly with pride, regardless of sexual orientation, and without discrimination. Kathi continued with a discussion on the impact of DADT on families.

Denny Meyer, AVER Public Affairs Officer, has recently represented AVER via mainstream and gay media Op Ed articles and interviews for print, internet and radio as well as speaking publicly at universities and organizations.

In October, Denny gave the National Coming Out Day commencement speech at Brown University in Providence Rhode Island. In March he spoke on the Public Policy Panel at the Harvard Law School Lambda DADT conference, and at the Queens County Ethical Culture Society in New York City.

Last Autumn, he was interviewed live on the Sue Wiley Show on the ABC affiliate statewide in Tennessee, speaking about the history of gay

and minority service members in the military. He then responded to listener call-in questions and commentary. One caller, with a rich blue-grass accent said that he did not believe that blacks, women, nor homosexuals had any place in our military because they were simply too much trouble. Knowing the answer, Denny asked the caller if he'd ever served in the military. Of course, he said, "no." Denny then explained that in our armed forces we all work together as a team and all service members must be 'team players' in order to qualify for the honor of serving our nation.

Similarly, when a caller raised the 'shower issue,' Denny asked him if he'd ever served; again the answer was, "no." Denny then explained that in the military we get up at 5:30 AM and at that hour no one wants to look at anyone, period; we take a two minute shower and all we can think about is getting to the mess hall for coffee and food. In the military, he told the caller, we are professionals who put aside our private lives in order to work together to defend freedom. End of story.

Among numerous other newspaper and radio interviews, Denny recently spoke on NPR (National Public Radio) regarding the homophobic comments made by JCS Chairman Gen. Peter Pace. In January, when General Shalikashvili spoke out for the repeal of DADT, quotes from AVER officers were sent to gay publications for inclusion in news articles, an Op Ed with those quotes was published in The Gay Military Times and the New York Blade, and a press release was sent to AP and other mainstream and gay media. Press releases are also sent to AVER chapters and Regional VPs for redistribution to local and regional media.

In March, AVER Public Affairs launched a Congressional Call Campaign, in coordination with

Vice President Veterans Affairs

AVER Veterans Affairs is developing a framework to gear up AVER's VSO services. Via former VP Dave Gainer and AVER Treasurer Mark LaFontaine's tireless efforts, the IRS recently granted AVER 501(c)(19) status which qualifies AVER to be Chartered by Congress as a VSO. Once the latter occurs, AVER will be able to send volunteers to be trained by the VA as Certified Veteran Service Officers (CVSO).

We will then be able to begin providing services to LGBT vets at the chapter and regional level which are similar to those provided by the much larger organizations, guiding our own with regards to benefits, disability claims, discharge upgrades, and other needs.

Volunteers with experience and time for responding to LGBT veterans service needs are now needed on several levels. At the first level, AVER chapter / regional 'limited' Veteran Service Officers will establish relations with and obtain guidance from local County CVSOs, DAV, and other veteran service organizations; and then provide guidance to LGBT vets seeking assis-

Additionally, volunteer coordinators are needed to establish and maintain our VSO network. You must have experience and time to devote to this effort.

Currently, AVER Veterans Affairs continues to provide guidance and referral to LGBT vets who contact us for assistance via internet and telephone inquiries.

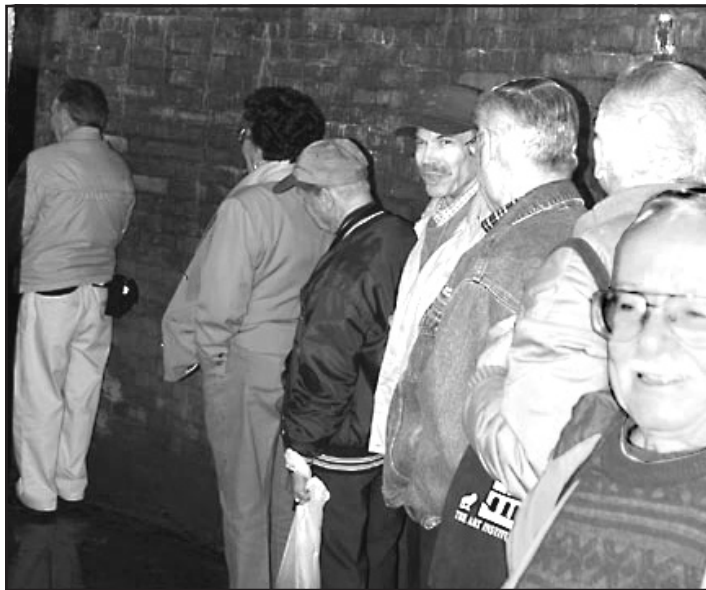

AVER Georgia founder and former President Jeff Cleghorn hosted a party at his home June 23 during Atlanta's annual Pride Festival for Petty Officer 2nd Class Stephen Benjamin, a high profile Arab linguist recently discharged from the US Navy under DADT.

Benjamin has used his discharge to help publicize the inherent danger of the DADT policy, appearing on CNN's Paula Zahn Live and The Colbert Report, and had an Op-ed published in the New York Times.

Also present at Cleghorn's party was Navy CTI3 Davie Santos, the Iraq veteran "adopted" by AVER Georgia while serving overseas, along with a dozen young active duty LGBT service members from Georgia.

Santos, also an Arab linguist and also discharged under DADT following his return from Fallujah last spring where he was attached to marine unit, was presented with a gold

service bracelet from AVER Georgia at the party to honor his service in the US military.

On Pride Sunday, AVER Georgia's color guard lead the annual Pride Parade with a contingent of 8 flags, 2 rifles, and 2 vehicles carrying veterans from Iraq, Afghanistan, the Gulf War, Vietnam, Korea, and World War II. We were very proud to have Davie march with us in the parade.

Following the parade, AVER opened the Sunday program with a taps ceremony from the main festival stage. The ceremony included World War II veteran Jack Strouss, who served under George S. Patton and who celebrated his 84th birthday that very day. Also participating in the ceremony was Monica Helms, national president of Transgender American Veterans Association (TAVA) who is a third generation Navy veteran and whose son is currently serving in the US Marines in Iraq. The ceremony featured both a bugle and a trumpet playing "echo" taps, which was extremely well received by the audience in Atlanta's Piedmont Park.

We encourage you to take advantage of this resource already just a click away. More functions will come on line in just a few months.

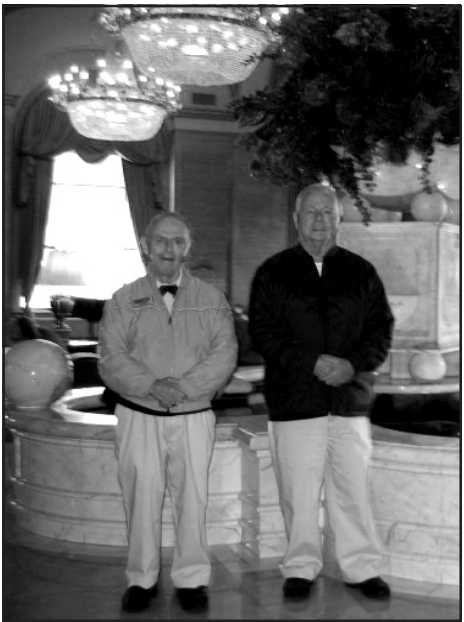

Chapter Reports

★AVER Region I



After having been discriminated against, by the parade organizers, in the 2005 NYC Veterans Day Parade, we were determined to be very visible in 2006. On November 11th 2006 AVER-NY had a block-long contingent composed of the Lesbian and Gay Big Apple Corps Marching Band with dancers, rainbow color guard, acrobats, the band playing Americana; and AVER-NY members and supporters. AVER-NY marchers were led by WWII Vet Major Willit Fields; and Rhonda Davis. The crowds cheered and loved us. The parade organizers (having been called on the carpet, for the previous year's discrimination, by Out Lesbian New York City Council Speaker Chris Quinn) treated us with



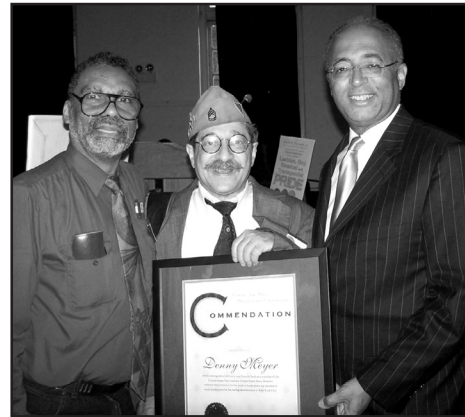
2006 NYC Veteran's Day Parade - photo courtesy of Denny Meyer

total respect and announced us from the reviewing stand at Times Square.

AVERNY president Denny Meyer helped organize and spoke at local DADT conferences at Hofstra University and Columbia University. He and AVERNY Vice President James Reilly participated in NY City Council Veterans Committee meetings which focused on advocating for City funding for local NYC Vet Resource Centers. AVERNY board members, in an effort led by Claude Ashby Jr., have been visiting and keeping track of hospitalized members and seeing to their needs.

The 2007 AVERNY Pride Awards in May honored NYC Congressman Gary Ackerman (who spoke out while questioning Secretary of State Condolanza Rice, suggesting that the State Dept. hire American military trained linguists who were discharged due to DADT), and among others our chapter treasurer, John Pulhamus, for his tireless efforts.

In May 2007, Denny Meyer, Pres. of AVER-NY, received a New York City Commendation proclamation, at the NYC Comptroller's annual Pride awards, for his service and "for his work in breaking down the barriers to social justice." Accepting the honor, Denny said: ...

"The Right of gay people to choose to volunteer to serve in America's Armed Forces, openly in Pride, without discrimination, is no different from the right to Choose to MARRY, nor from all the other rights and responsibilities that we demand."

When President Truman integrated our armed forces by executive order in 1948, Bigots told Truman that they could not shower with nor take orders from Black Americans. His order may have set the precedent for the civil rights that *nearly* all Americans now enjoy.

Today, bigots say that they cannot shower with nor take orders from Gay Americans. The Military Readiness Enhancement Act, which would repeal Dont Ask Dont Tell, is currently in the US House of Representatives, and will soon be introduced in the United States Senate, and it will be signed by the *next* president.

It has been such a long time since a few brave souls stood shouting at police in Sheridan Square. Yet, from the streets to seats at the table, from Stonewall to the Senate, our struggle for freedom and full inclusion in American Equality has persevered, we shall prevail, we will win."

our liaison work with a local organization, TransFamily of Cleveland, which has helped many transveterans in our region, as well as nationally. Our local VA clinicians are extremely protective of transveterans, as well they should be, so until we heard it come directly from one transveteran, we were completely unaware that many local transveterans are referred directly to TFC as a local support group *by* VA clinicians.

NEOAVR had a fairly quiet summer in "recovery" from the convention, but we are looking forward to some "socials" this Fall and Winter to get things back into high gear.
